Subject : Change of Category of school from Regular Affiliation to General Affiliation - reg.

Sir/Madam,

The Board has notified its revised Affiliation Bye-Laws, 2018 vide notification dated 18.10.2018.

The Bye-Laws defines the framework within which the activities of the schools would be conducted to ensure that the spirit of value-based education, fairness, and the rules are being followed in letter and spirit by the schools.

The Board has restructured the categories of schools affiliated with the Board as mentioned in rule 2.1 of Affiliation Bye-Laws -2018. Hence, all regular affiliated schools which earlier fall under regular affiliation category will now onwards treated under General Affiliation.

Rule	Category of school
2.1.5	Schools managed directly by (Central or State) Public Sector Undertakings, Statutory Bodies and Autonomous Bodies etc.;
2.1.6	Schools managed by Societies formed by (Central or State) Public Sector Undertakings, Statutory Bodies, Autonomous Bodies and Government Departments etc.;
2.1.7	Schools managed by Societies for (Central or State) Public Sector Undertakings, Statutory Bodies, Autonomous Bodies and Government Departments etc. under the financial control of such Public Sector Undertakings, Statutory Bodies, Autonomous Bodies and Government Departments etc.;
2.1.8	Private schools established by (a) Societies registered under the Societies Registration Act 1860 of the Government of India or under Acts of the State Governments as educational, charitable or religious societies having non-proprietary character or (b) by Registered Trusts or (c) Companies registered under section 8 of the Companies Act-2013, having education as one of its objects.

Therefore, your school is now considered under category of General Affiliation and the new affiliation number under General Affiliation Category is **1730054**.

Your school therefore needs to apply online for affiliation upgradation additional subject(s) etc. or other provisions as laid down in Chapter -15 of the Affiliation Bye-Laws, as the case may be with requisite fee at [www.cbseaff.nic.in](http://www.cbseaff.nic.in) for the session commencing from 2020-21. The school are also required to apply for extension of affiliation through online mode only for a period of five years for the session commencing from 2020-21 along with requisite fee even if the fee for annual extension has been paid beyond session 2019-20. The excess fee paid, if any, shall be refunded on applying to CBSE. The link for the purpose shall be functional from 01.06.2019 to 31.10.2019.




No separate letter will be issued for extension of affiliation as such, the school has already been granted regular affiliation.


